- The CITY GOVERNMENT OF CALAMBA through the General Fund (2014) intends to apply the sum of PHP **91,360.00** being the Approved Budget for the Contract (ABC) to payments under the contract for:

**G-2014-488 SUPPLY AND DELIVERY OF MEDICAL EQUIPMENT
City Health Services Department-Nutrition**

Bids received in excess of the ABC shall be automatically rejected at Bid opening.
- The City Government of Calamba now invites bids for the above stated procurement. Delivery of the GOODS is required within **Seven (7) calendar days**. Bidders should have completed, within the last two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 and subject to Commonwealth Act 138.
- Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.

A complete set of Bidding Documents may be purchased by interested Bidders or his duly authorized representative on **Nov. 12 to 19, 2014(10AM)** from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of **Php 500.00**
- Bids must be delivered by the Bidder or his duly authorized representative, to the address below on or before **10:00 AM November 19, 2014** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in in ITB Clause 18.


