2.	<p>The City Government of Calamba now invites bids for the above stated procurement. Delivery of the GOODS is required within <b>Fourteen (14) calendar days</b>. Bidders should have completed, within the last two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.</p>
3.	<p>Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act."</p> <p>Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 and subject to Commonwealth Act 138.</p>
4.	<p>Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.</p> <p>A complete set of Bidding Documents may be purchased by interested Bidders or his duly authorized representative on <b>Nov. 21 to 28, 2014 (9AM)</b> from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of <b>Php 1,250.00</b></p>
5.	<p>Bids must be delivered by the Bidder or his duly authorized representative, to the address below on or before <b>9:00 AM November 28, 2014</b> All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in <b>ITB Clause 18</b>.</p>
