2.	The City Government of Calamba now invites bids for the above stated procurement. Delivery of the GOODS is required within <i>Twenty-One (21) calendar days</i> . Bidders should have completed, within the last two (2) years from the date of submission an receipt of bids, a contract similar to the Project. 3.	Bidding will be conducted through open competitive bidding procedures using a nor discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of
	Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act."
	Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations wit at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which gran similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 and subject to Commonwealth Act 138.
