The City Government of Calamba now invites bids for the above stated procurement. Completion of the Works is required within <i>Thirty (30) calendar days</i>. Bidders should have completed, within the last ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act."</p> <p>Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.</p> <p>4. Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.</p> <p>5. A complete set of Bidding Documents may be purchased by interested Bidders or his duly authorized representative on Nov. 6 to 13, 2014 from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Php 750.00</p> <p>6. Bids must be delivered by the Bidder or his duly authorized representative, to the address below on or before 9:00 AM November 14, 2014. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in in ITB Clause 18.</p> <p>Bid opening shall be on November 14, 2014 10:00 AM at the BAC Office, LG/F 25 Calamba City Hall. Bids will be opened in the presence of the Bidders or the Bidders' authorized representatives who choose to attend.
