1.	<p>The CITY GOVERNMENT OF CALAMBA through the General Fund intends to apply the sum of <b>Php 498,918.40</b> being the Approved Budget for the Contract (ABC) to payments under the contract for:</p> <p style="text-align: center;"><b>G-2015-826 SUPPLY AND INSTALLATION OF SECURITY SURVEILLANCE SYSTEM Barangay Prinza</b></p> <p>Bids received in excess of the ABC shall be automatically rejected at Bid opening.</p>
2.	<p>The City Government of Calamba now invites bids for the above stated procurement. Delivery of the GOODS is required within <b>Thirty (30) calendar days</b>. Bidders should have completed, within the last two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.</p>
3.	<p>Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act."</p> <p>Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 and subject to Commonwealth Act 138.</p>
4.	<p>Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.</p> <p>A complete set of Bidding Documents may be acquired by interested Bidders or his duly authorized representative on <b>Nov. 18 to 24, 2015</b> from the address below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php500.00.</p>
5.	<p>Bids must be delivered by the Bidder or his duly authorized representative, to the address below on or before <b>10:00 AM November 25, 2015</b>. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.</p>
