
1. The CITY GOVERNMENT OF CALAMBA through the General Fund intends to apply the sum of **Php 499,942.40** being the Approved Budget for the Contract (ABC) to payments under the contract for:  

**G-2015-890     SUPPLY AND DELIVERY OF BOOKS  
Calamba City College**

Bids received in excess of the ABC shall be automatically rejected at Bid opening.
2. The City Government of Calamba now invites bids for the above stated procurement. Delivery of the GOODS is required within **Twenty-One (21) calendar days**. Bidders should have completed, within the last two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act."  
  
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 and subject to Commonwealth Act 138.
4. Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.  
  
A complete set of Bidding Documents may be acquired by interested Bidders or his duly authorized representative on **Nov. 5 to 12, 2015** from the address below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php500.00**.
5. Bids must be delivered by the Bidder or his duly authorized representative, to the address below on or before **9:00 AM November 13, 2015**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.
