Section I. INVITATION TO BID

1. The CITY GOVERNMENT OF CALAMBA through the LDRRMF intends to apply the sum of **Php 62,604.80** being the Approved Budget for the Contract (ABC) to payments under the contract for:

**G-2015-956 SUPPLY AND DELIVERY OF MEDICAL SUPPLIES-EQUIPMENT
CDRRMC**

Bids received in excess of the ABC shall be automatically rejected at Bid opening.

2. The City Government of Calamba now invites bids for the above stated procurement. Delivery of the GOODS is required within **Seven (7) calendar days**. Bidders should have completed, within the last two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 and subject to Commonwealth Act 138.



5. Bids must be delivered by the Bidder or his duly authorized representative, to the address below on or before **10:00 AM December 1, 2015**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.
