	Bids received in excess of the ABC shall be automatically rejected at Bid opening.
2.	The City Government of Calamba now invites bids for the above stated procurement. Completion of the Works is required within <i>Ninety (90) calendar days</i> . Bidders should have completed, within the last ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. 3.	Bidding will be conducted through open competitive bidding procedures using a non discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) or
	Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act."
	Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations wit at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
