2.	The City Government of Calamba now invites bids for the above stated procurement. Completion of the Works is required within <i>Fifty-Six (56) calendar days</i> . Bidders should have completed, within the last ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3.	Bidding will be conducted through open competitive bidding procedures using a non discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) o Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act."
	Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

The BAC of the City Government of Calamba will hold a Pre-Bid Conference which shall be open only to all interested Bidders, or its duly authorized representative, who have purchased the Bidding Documents, to be held at the Conference Room, Nutrition Office Calamba City Hall Complex on Mar. 6, 2015 at 10:00 AM
7.	Bids must be delivered by the Bidder or his duly authorized representative, to the address below on or before 10:00 AM March 18, 2015 All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
