



1.	<p>The CITY GOVERNMENT OF CALAMBA through the Special Education Fund intends to apply the sum of PHP 10,170,027.06 being the Approved Budget for the Contract (ABC) to payments under the contract for:</p> <p style="text-align: center;">I-2015-015 CONSTRUCTION OF 3-STY 6-CL SCHOOLBUILDING/Palo Alto NHS, Barangay Palo Alto</p> <p>Bids received in excess of the ABC shall be automatically rejected at Bid opening.</p>	
2.	<p>The City Government of Calamba now invites bids for the above stated procurement. Completion of the Works is required within One Hundred Sixty-Four (164) calendar day. Bidders should have completed, within the last ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.</p>	
3.	<p>Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act."</p> <p>Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.</p>	
4.	<p>Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.</p>	
5.	<p>A complete set of Bidding Documents may be purchased by interested Bidders or his duly authorized representative on April 30 to May 7, 2015 from the address below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php25,000.00.</p>	
6.	<p>The BAC of the City Government of Calamba will hold a Pre-Bid Conference which shall be open only to all interested Bidders, or its duly authorized representative, who have purchased the Bidding Documents, to be held at the BAC Office, LG/F 25 Calamba City Hall on May 8, 2015 at 10:00 AM</p>	
7.	<p>Bids must be delivered by the Bidder or his duly authorized representative, to the address below on or before 10:00 AM May 20, 2015. All Bids must be accompanied by a bid security certificate, the attached forms and in the amount stated in ITB Clause 18.</p>
