3.	<p>Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act."</p> <p>Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.</p>
4.	<p>Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.</p>
5.	<p>A complete set of Bidding Documents may be purchased by interested Bidders or his duly authorized representative on May 28 to June 4, 2015 from the address below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php10,000.00.</p>
6.	<p>The BAC of the City Government of Calamba will hold a Pre-Bid Conference which shall be open only to all interested Bidders, or its duly authorized representative, who have purchased the Bidding Documents, to be held at the BAC Office, LG/F 25 Calamba City Hall on June 5, 2015 at 10:00 AM</p>
