The City Government of Calamba now invites bids for the above stated procurement. Completion of the Works is required within <b>Eight (8) calendar days</b>. Bidders should have completed, within the last ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the <i>Bidding Documents</i>, particularly, in Section II. Instructions to Bidders.</p> <p>3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act."</p> <p>Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.</p> <p>4. Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.</p> <p>5. A complete set of Bidding Documents may be purchased by interested Bidders or his duly authorized representative on <b>June 18 to 25, 2015</b> from the address below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php5,000.00.</p> <p>6. The BAC of the City Government of Calamba will hold a Pre-Bid Conference which shall be open only to all interested Bidders, or its duly authorized representative, who have purchased the Bidding Documents, to be held at the BAC Office, LG/F 25 Calamba City Hall on <b>June 26, 2015 at 10:00 AM</b></p> <p>7. Bids must be delivered by the Bidder or his duly authorized representative, to the address below on or before <b>10:00 AM July 8, 2015</b>. All Bids must be accompanied by a bid security in any of the acceptable forms set in the amount stated in <b>ITB Clause 18</b>.</p>
