	Bids received in excess of the ABC shall be automatically rejected at Bid opening.	
2.	The City Government of Calamba now invites bids for the above stated procurement. Completion of the Works is required within <i>Thirty (30) calendar days</i> .  Bidders should have completed, within the last ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.	
3.	Bidding will be conducted through open competitive bidding procedures using a non discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act."	
	Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organization with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
