4.	<p>Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.</p>	
5.	<p>A complete set of Bidding Documents may be purchased by interested Bidders or his duly authorized representative on <b>Sept. 22 to 29, 2015</b> from the address below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of <b>Php5,000.00</b>.</p>	
6.	<p>The BAC of the City Government of Calamba will hold a Pre-Bid Conference which shall be open only to all interested Bidders, or its duly authorized representative, who have purchased the Bidding Documents, to be held at the BAC Office, LG/F 25 Calamba City Hall on <b>Sept. 30, 2015 at 2:00 PM</b></p>
