Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organization with at least seventy-five percent (75%) interest or outstanding capital stock belonging citizens of the Philippines.

A complete set of Bidding Documents may be purchased by interested Bidders or his duly authorized representative on Sept. 24 to Oct. 1, 2015 from the address below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php500.00.			
6.	Bids must be delivered by the Bidder or his duly authorized representative, to the address below on or before 9:00 AM October 2, 2015 All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
