- The CITY GOVERNMENT OF CALAMBA through the General Fund intends to apply the sum of **PHP 9,998,792.08** being the Approved Budget for the Contract (ABC) to payments under the contract for:


I-2015-140 REHABILITATION OF CALAMBA CITY HALL/Calamba City Hall Complex

Bids received in excess of the ABC shall be automatically rejected at Bid opening.
- The City Government of Calamba now invites bids for the above stated procurement. Completion of the Works is required within **One Hundred Fifty (150) calendar days**. Bidders should have completed, within the last ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.
- A complete set of Bidding Documents may be purchased by interested Bidders or his duly authorized representative on **Nov. 9 to 16, 2015 (until 10AM)** from the address below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php10,000.00**.
- The BAC of the City Government of Calamba will hold a Pre-Bid Conference which shall be open only to all interested Bidders, or its duly authorized representative, who have purchased the Bidding Documents, to be held at the BAC Office, LG/F 25 Calamba City Hall on **Nov. 16, 2015 at 2:00 PM**
- Bids must be delivered by the Bidder or his duly authorized representative, to the address below on or before **10:00 AM December 1, 2015**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
