2.	<p>The City Government of Calamba now invites bids for the above stated procurement. Completion of the Works is required within <b>Sixty (60) calendar days</b>. Bidders should have completed, within the last ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. 3.	<p>Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act."</p> <p>Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.</p>
4.	<p>Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.</p>
5.	<p>A complete set of Bidding Documents may be purchased by interested Bidders or his duly authorized representative on <b>Nov. 25 to Dec. 1, 2015</b> from the address below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php5,000.00.</p>
