4.	<p>Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.</p>	
5.	<p>A complete set of Bidding Documents may be acquired by interested Bidders or his duly authorized representative from the address below and upon payment of a non-fee for the Bidding Documents pursuant to the latest Guidelines issued by the GPPB, in the amount of Php500.00.</p>	
6.	<p>Bids must be delivered by the Bidder or his duly authorized representative, to the address below on or before 10:00 AM November 9, 2016. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.</p> <p>Bid opening shall be on November 9, 2016 2:00 PM at the BAC Office, LG/F 25 Calamba City Hall.
