Bidders should have completed, within the last ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act."</p> <p>Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.</p> <p>4. Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.</p> <p>5. A complete set of Bidding Documents may be acquired by interested Bidders or his duly authorized representative from the address below and upon payment of a non-fee for the Bidding Documents pursuant to the latest Guidelines issued by the GPPB, in the amount of Php1,000.00.</p> <p>6. Bids must be delivered by the Bidder or his duly authorized representative, to the address below on or before 10:00 AM October 10, 2016. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in in ITB Clause 18.</p> <p>Bid opening shall be on October 10, 2016 2:00 PM at the BAC Office, LG/F 25 Calamba City Hall. Bids will be opened in the presence of the Bidders or the Bidders' authorized representatives who choose to attend. Late bids shall not be accepted.</p>
