- The CITY GOVERNMENT OF CALAMBA through the General Fund intends to apply the sum of **PHP 1,999,242.00** being the Approved Budget for the Contract (ABC) to payments under the contract for:

I-2016-107 ASPHALTING OF ROAD/Barangay Bañadero

Bids received in excess of the ABC shall be automatically rejected at Bid opening.

- The City Government of Calamba now invites bids for the above stated procurement. Completion of the Works is required within **Two (2) calendar days**. Bidders should have completed, within the last ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

- Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.


