Bidders should have completed, within the last two (2) years from the date of submission and receipt of bids, a contract similar to the Project. 3.	Bidding will be conducted through open competitive bidding procedures using a non
	discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR
	of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act."
	Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which gran similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 and subject to Commonwealth Act 138.
4.	Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.
5.	A complete set of Bidding Documents may be acquired by interested Bidders or hiduly authorized representative from the address below and upon payment of a non-refundable fee for the Bidding Documents pursuant to the latest Guidelines issued by the GPPB, in the amount of Php5,000.00.
