





1.	<p>The CITY GOVERNMENT OF CALAMBA through the LGDF intends to apply the sum of <b>PHP 2,358,596.08</b> being the Approved Budget for the Contract (ABC) to payments under the contract for:</p> <p style="text-align: center;"><b>I-2016-163 REPAIR/IMPROVEMENT OF HOUSING UNITS (PH.2)/Calambeño Ville 5, Ph.1, Barangay Kay-Anlog</b></p> <p>Bids received in excess of the ABC shall be automatically rejected at Bid opening.</p>
2.	<p>The City Government of Calamba now invites bids for the above stated procurement. Completion of the Works is required within <b>One Hundred Twenty (120) calendar days</b>. Bidders should have completed, within the last ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.</p>
3.	<p>Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act."</p> <p>Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.</p>
4.	<p>Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.</p>
5.	<p>A complete set of Bidding Documents may be acquired by interested Bidders or his duly authorized representative from the address below and upon payment of a non-refundable fee for the Bidding Documents pursuant to the latest Guidelines issued by the GPPB, in the amount of <b>Php5,000.00</b>.</p>
6.	<p>The BAC of the City Government of Calamba will hold a Pre-Bid Conference which shall be open to all interested Bidders, or its duly authorized representative, to be held at the BAC Office, LG/F 25, Calamba City Hall on <b>March 8, 2017 at 2:00 PM</b></p>
7.	<p>Bids must be delivered by the Bidder or his duly authorized representative, to the address below on or before <b>10:00 AM March 20, 2017</b> All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in <b>ITB Clause 18</b>.</p>
