Section I. INVITATION TO BID

1. The CITY GOVERNMENT OF CALAMBA through the LDRRMF intends to apply the sum of **PHP 3,640,797.60** being the Approved Budget for the Contract (ABC) to payments under the contract for:

**G-2017-1131 SUPPLY AND INSTALLATION OF FURNITURE & FIXTURES
Office of the City Mayor-Local Disaster Risk
Reduction Management Division**

Bids received in excess of the ABC shall be automatically rejected at Bid opening.

2. The City Government of Calamba now invites bids for the above stated procurement. Delivery of the GOODS is required within **Thirty (30) calendar days**. Bidders should have completed, within the last two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act."
- Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183.
4. Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.
5. A complete set of Bidding Documents may be acquired by interested Bidders or his duly authorized representative from the address below and upon payment of a non-refundable fee for the Bidding Documents pursuant to the latest Guidelines issued by the GPPB, in the amount of Php5,000.00.
6. The BAC of the City Government of Calamba will hold a Pre-Bid Conference which shall be open to all prospective Bidders, or its duly authorized representative to be held at the BAC Office, LG/F 25, Calamba City Hall on **November 15, 2017 at 2:00 PM.**

7. Bids must be delivered by the Bidder or his duly authorized representative, to the address below on or before **10:00 AM November 27, 2017**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **November 27, 2017 2:00 PM** at the BAC Office, LG/F 25 Calamba City Hall. Bids will be opened in the presence of the Bidders or the Bidders' authorized representatives who choose to attend. Late bids shall not be accepted.

The HOPE of the City Government of Calamba reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected Bidder or Bidders.


