Section I. INVITATION TO BID

1. The CITY GOVERNMENT OF CALAMBA through the Special Education Fund intends to apply the sum of **PHP 1,799,997.79** being the Approved Budget for the Contract (ABC) to payments under the contract for:

I-2017-115 Improvement of Classrooms/Mayapa ES, Brgy. Mayapa

Bids received in excess of the ABC shall be automatically rejected at Bid opening.

2. The City Government of Calamba now invites bids for the above stated procurement. Completion of the Works is required within **Forty five (45) calendar days**. Bidders should have completed, within the last ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A.) 9184, otherwise known as the "Government Procurement Reform Act."
- Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.
5. A complete set of Bidding Documents may be acquired by interested Bidders or his duly authorized representative from the address below and upon payment of a non-refundable refundable fee for the Bidding Documents pursuant to the latest Guidelines issued by the GPPB, amount of Php5,000.00.
6. The BAC of the City Government of Calamba will hold a Pre-Bid Conference which shall be open to all prospective bidders, or its duly authorized representative, to be held at the BAC Office, LG/F 25, Calamba City Hall on **September 13, 2017 at 2:00 PM.**
7. Bids must be duly received by the Bidder or his duly authorized representative, to the address below on or before **10:00 AM September 25, 2017**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in in ITB Clause 18.

CERTIFIED PHOTOCOPY:

Bid opening shall be on **September 25, 2017 2:00 PM** at the BAC Office, LG/F 25 Calamba City Hall Complex. Bids will be opened in the presence of the Bidders or the Bidders' authorized representatives who choose to attend. Late bids shall not be accepted.

The HOPE of the City Government of Calamba reserves the right to reject any and all bids, declare a failure of bidding or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected Bidder or Bidders.
