Completion of the Works is required within Sixty (60) calendar days. Bidders should have completed, within the last ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.</p> <p>3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A.) 9184, otherwise known as the "Government Procurement Reform Act."</p> <p>Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.</p> <p>4. Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.</p> <p>5. A complete set of Bidding Documents may be acquired by interested Bidders or his duly authorized representative from the address below and upon payment of a non-refundable refundable fee for the Bidding Documents pursuant to the latest Guidelines issued by the GPPB, amount of Php5,000.00.</p> <p>6. The BAC of the City Government of Calamba will hold a Pre-Bid Conference which shall be open to all prospective bidders, or its duly authorized representative, to be held at the BAC Office, LG/F 25, Calamba City Hall on April 27, 2018 at 10:00 AM.</p> <p>7.
