



**Section I. INVITATION TO BID**

1.	<p>The CITY GOVERNMENT OF CALAMBA through the General Fund intends to apply the sum of <b>PHP 2,505,600.00</b> being the Approved Budget for the Contract (ABC) to payments under the contract for:</p> <p><b>G-2019-408 SUPPLY AND DELIVERY OF CONSTRUCTION MATERIALS</b> <b>City Engineering and Infrastructure Dev't. Dept.</b></p> <p>Bids received in excess of the ABC shall be automatically rejected at Bid opening.</p>
2.	<p>The City Government of Calamba now invites bids for the above stated procurement. Delivery of the GOODS is required within <b>Fourteen (14) calendar day/s</b>. Bidders should have completed, within the last two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.</p>
3.	<p>Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act."</p> <p>Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183.</p>
4.	<p>Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.</p>
5.	<p>A complete set of Bidding Documents may be acquired by interested Bidders or his duly authorized representative from the address below and upon payment of a non-refundable fee for the Bidding Documents pursuant to the latest Guidelines issued by the GPPB, in the amount of Php5,000.00.</p>
6.	<p>The BAC of the City Government of Calamba will hold a Pre-Bid Conference which shall be open to all prospective Bidders, or its duly authorized representative to be held at the BAC Office, LG/F 25, Calamba City Hall on <b>June 7, 2019 at 10:00 AM.</b></p>
