Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before May 29, 2019, 10:00 AM and shall be opened on May 29, 2019, 2:00 PM at the BAC Office, LGF/25 Calamba City Hall. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.
3.	Interested Consultant(s) or his duly authorized representative(s) may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below during 8:00 AM to 5:00 PM.
4.	A complete set of Bidding Documents may be acquired by interested Consultants or his dul authorized representative(s) on June 13, 2019 to June 18, 2019 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of PhP5.000.00.
5.	The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the Eligibility Documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act," and its Implementing Rules and Regulations (IRR). The short list shall consist of five (5 prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:
	 (a) Applicable experience of the consultant and members in case of joint ventures, considering both the overall experiences of the firm or, in the case of new firms, the individual experiences of the principal and key staff, including the times when employed by other consultants;
	(b) Qualification of personnel who may be assigned to the job vis-a-vis extent and complexity of the undertaking; and
