



1.	<p>The CITY GOVERNMENT OF CALAMBA through the General Fund intends to apply the sum of PHP <b>6,999,719.45</b> being the Approved Budget for the Contract (ABC) to payments under the contract for:</p> <p style="text-align: center;"><b>I-2023-007 Construction of Covered Court/Sitio GK, Carmelray, Barangay Canlubang</b></p> <p>Bids received in excess of the ABC shall be automatically rejected at Bid opening.</p>
2.	<p>The City Government of Calamba now invites bids for the above stated procurement. Completion of the Works is required within <b>One hundred thirty eight (138) calendar day</b>. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.</p>
3.	<p>Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A.) 9184.</p>
4.	<p>Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.</p>
5.	<p>A complete set of Bidding Documents may be acquired by interested Bidders or his duly authorized representative on <b>February 3, 2023</b> to <b>February 22, 2023</b> from given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the <b>amount of Php10,000.00</b>. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person</p>
6.	<p>The BAC of the City Government of Calamba will hold a Pre-Bid Conference on <b>February 10, 2023 at 10:00 AM</b> at the BAC Office, LG/F 25, Calamba City Hall, which shall be open to prospective bidders or his duly authorized representative.</p>
7.	<p>Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before <b>9:00 AM February 22, 2023</b>. Late bids shall not be accepted.</p>
8.	<p>All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.</p>
