I-2023-072 Installation of Streetlights/Barangay Majada-Out

Bids received in excess of the ABC shall be automatically rejected at Bid opening.

- The City Government of Calamba now invites bids for the above stated procurement. Completion of the Works is required within **Twenty five (25) calendar day/s**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
 - Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (R.A.) 9184.
 - Interested Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.
 - A complete set of Bidding Documents may be acquired by interested Bidders or his duly authorized representative on **September 6, 2023** to **September 25, 2023** from given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the **amount of Php5,000.00**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person
 - The BAC of the City Government of Calamba will hold a Pre-Bid Conference on **September 13, 2023 at 2:00 PM** at the BAC Office, LG/F 25, Calamba City Hall, which shall be open to prospective bidders or his duly authorized representative.
 - Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before **9:00 AM September 25, 2023** Late bids shall not be accepted.
- All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.
