Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184.  a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with		
	at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the		
	Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183.		
4.	Prospective Bidders or his duly authorized representative may obtain further information from the City Government of Calamba and inspect the Bidding Documents at the address given below from 8:00 AM - 5:00 PM.

A complete set of Bidding Documents may be acquired by interested Bidders or his duly authorized representative on April 5, 2024 to April 24, 2024 from the address below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, amount of Php10,000.00.
